Goal

Objectives

1. To encourage communication between the home and school that is regular, two-way and meaningful.
2. To recognize parents as their children's first teachers and that they are the key to their success in school and beyond.
3. To enhance student achievement by including parents in the student learning process.
4. To increase volunteerism by parents in public schools.
5. To include parents in decision making and advocacy in education.

Grant

1. The maximum amount of the grant will be \$500.00.
2. Applications must be postmarked by October 15.
3. Winners will be notified prior to convention.
4. All winners will receive their checks and be recognized at the State Convention.

Requirements

1. Local unit must complete the application in its entirety. Application can be found on back.
2. Local unit must have current bylaws on file with Maryland PTA.
3. At the time of the application, National and State dues must be current.
4. Winners will submit a written report on the implementation of their program and the outcome of their efforts by June 1.
